I, THE ABOVE-NAMED DEFENDANT, have been charged with the offense of:

Should I be found NOT GUILTY, I will be released at that time. On a finding of GUILTY, a fine and court costs will be assessed. NOTICE OF MY COURT DATE WILL BE MAILED FIRST CLASS MAIL TO THE ADDRESS I LIST BELOW. I WILL MAINTAIN A CURRENT ADDRESS WITH THE COURT AND APPEAR AS ORDERED.

(I understand that if I do not plead at this time, a plea of NOT GUILTY will be entered for me by the Court, that I must appear for trial, and I must keep the Court advised of my current address.)

4. ____ I REQUEST JAIL CREDIT to cover my fines and court costs.
